Auditor Walder swore in Helga Davies, owner. Auditor Walder noted for the record that the Auditor's office has the parcel in question valued at \$110,000 yet she feels it is worth \$90,000 and the Board asked her to explain why the value should be reduced.

Ms. Davies presented Exhibits A, B, and C that included a home photo, Geauga County Laboratory report and a wrapped cloth discolored by the water issue. Owner went over water damage issues to the property and exterior damage to the roof of the home leading into the foundation, cost of repairs and financial hardship. The lake on her property is not able to be used for recreational purposes due to exposed septic from the neighboring property flowing onto hers. She is

unable to maintain a garden as well. Chris did a field check, went over comparables for Hambden Township. Auditor Walder asked questions regarding other property issues and Timothy C. Lennon asked questions regarding previous decrease in property value to Chris Greenawalt.

Auditor Walder swore in Donna Baumann, owner. Auditor Walder noted for the record that the Auditor's office has the parcel in question valued at \$176,100 yet she feels it is worth \$129,600 and the Board asked her to explain why the value should be reduced.

Mrs. Baumann presented Exhibit A, tax value sheet of increase and decrease over 10 years and the historical background on the interior of the home including bathroom, chimney and bedroom issues. Exterior repairs as follows; 6 windows replaced for \$3,000, room replacement at \$16,000, garage repair of \$2,000, furnace replacement \$3,000, and an estimate to replace wood flooring for entire home was approximately \$15,000 and siding repair at \$25,000. Chris Greenawalt did a field check of interior inspection and went over comparables but this was difficult based on age of property. Auditor Walder asked if there had been an updated appraisal and that was not done.

After a review of all testimony and all the other information available it was motioned by Timothy C. Lennon, seconded by Caroline Mansfield to decrease the Market Value for Tax Year 2018 from \$176,100 to \$129,600 based on evidence presented.
