A discussion began with regard to final determination of the 0.6 of inside millage resulting from the territory transfer of Newbury LSD with West Geauga LSD. Based on research performed by the Prosecutor's office, it was determined that Newbury Twp. will receive the 0.6 inside millage effective with the 2022 collection.

The Budget Commission staff shared that Auburn Twp. and East Geauga Fire District have not turned in 2020YE or 2021 Permanent Appropriations, as of yet.
