The Geauga County Budget Commission met in special session on Tuesday June 22, 2021 at 10:06 a.m. in the Auditor's office at 215 Main Street, Chardon, Ohio. Present: Geauga County Auditor Charles E. Walder, Geauga County Prosecutor James R. Flaiz, and Geauga County Treasurer C. P. Hitchcock. Also Present: Chief Deputy Auditor Ron Leyde, Deputy Auditors, Tammy Most and Kristen Sinatra

Meting was advertised: Regular Business

There was a slight delay with proceeding as Prosecutor Flaiz was detained by an earlier meeting – James Flaiz arrived at 10:10 a.m.

At the request of the (Geauga) Board of County Commissioner's (BOCC) Prosecutor Flaiz attended their scheduled meeting. Prosecutor Flaiz presented the rationale behind the revisions to the formula for the alternate method of distribution for Undivided Local Government Revenue. The proposed change (Addendum I) had been approved originally by the Budget Commission on May 25, 2021 and further revised and approved on June 14, 2021. The Addendum I was then circulated for a vote to all Townships, Municipalities and BOCC.
