Taxes were erroneously charged and collected for property 29-108061 for Tax Years 2013-2019 in the amount of \$2,990.52. Ohio Revised Code only permits a five year claw back, therefore requiring a refund for Tax Years 2013-2017. Total tax paid to be refunded is \$2,990.52 plus interest in the amount of \$459.35 totaling the refund of \$3,449.87.
