



Pursuant to R.C. 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$2,301.65 (Two Thousand Three Hundred One Dollars and Sixty Five Cents) from 1001-008-00-601 to IBOLD & OBRIEN, at 401 SOUTH ST 1A, CHARDON, OH 44024, for attorney's fees for 09PG255, 11PG364, 20PG101 and 21PG108, which the Probate Court has determined to be an expenditure for a proper public purpose. Pursuant to R.C. 319.16(D), "if the auditor questions the validity of [this] expenditure... the auditor shall notify the court that presented the documents, shall issue the warrant under protest, and shall notify the auditor of state of the protest."




Fees and costs for the above guardianship in the amount of \$711.65 are ordered to be paid to Ibold & O'Brien by the Geauga County Probate Court.
