Pursuant to R.C. 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$2,301.65 (Two Thousand Three Hundred One Dollars and Sixty Five Cents) from 1001-008-00-601 to IBOLD & OBRIEN, at 401 SOUTH ST 1A, CHARDON, OH 44024, for attorney's fees for 09PG255, 11PG364, 20PG101 and 21PG108, which the Probate Court has determined to be an expenditure for a proper public purpose.
