Pursuant to R.C. 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$ 717.20 (Seven Hundred Seventeen Dollars and Twenty Cents) from 1001-008-00-601 to IBOLD & OBRIEN, at 401 SOUTH ST 1A, CHARDON, OH 44024, for attorney's fees for 21PG108 and 18PG199, which the Probate Court has determined to be an expenditure for a proper public purpose. 
