Pursuant to R.C. 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$1,575.00 (One Thousand Five Hundred Seventy Five Dollars and No Cents) from 1001-008-00-601 to LARRICK, SCOTT A, at 8442 MAYFIELD ROAD, CHESTERLAND, OH 44026, for attorney's fees for 20PG32, which the Probate Court has determined to be an expenditure for a proper public purpose. Pursuant to R.C. 319.16(D), "if the auditor questions the validity of [this] expenditure... the auditor shall notify the court that presented the documents, shall issue the warrant under protest, and shall notify the auditor of state of the protest."

Upon consideration, the Court approves the sum of \$1575.00 as guardian ad litem fees.


Said fee shall be paid from the Court's funds.
