Pursuant to R.C. 5705.42, 2303.201(E)(1), 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$1,091.65 (One Thousand Ninety One Dollars and Sixty Five Cents) from 2051-007-00-901 to KIMBERLY A. BAIONI, at DBA: BAIONI LAW, 7445 CENTER STREET, MENTOR, OH 44060, for attorney's fees for 18CU41 which the Juvenile Court has determined to be an expenditure for a proper public purpose.
