Commissioners,

Per your office's requirement of seven (7) day advance notice for agenda items, my office requested on August 22<sup>nd</sup> (see attached Session request) to be placed on tomorrow's (8/30/2022) agenda to present a variety of issues concerning the Chardon Township WWTP. For some unknown reason, your office has apparently denied that request (see attached ag 8-30-2022 agenda). Some of the issues regarding the WWTP are time sensitive and require specific action on your part for me to lawfully place the assessment on the 113 parcels this year. Absent your action by the 2<sup>nd</sup> Monday of September (per ORC 6117.33), I will be unable to do this work as your next scheduled meeting isn't until the Tuesday following that deadline. I assume that you accept this assessment delay and are prepared for the financial consequences at Water Resources.

As a courtesy, I am attaching the report (ChardonTwpWWTP) that I had prepared to present to you tomorrow. I had arranged for several members of my staff to be present to answer any specific questions that you may have regarding various aspects of the report's content but since we are not on the agenda, I have advised them to not attend. Since this assessment information is also important for the affected residents in Berkshire Heights, I will be posting it for their benefit on my office's Transparency website and advising them.

While the lack of timely communication from your office continues to be a disappointment, we will continue to do our best.
