Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$95.86 (Ninety Five Dollars and Eighty Six Cents) from 1001-007-02-701 to WESTERN RESERVE OFFICE SUPPLY, at PO BOX 167, CHARDON, OH 44024, for materials and supplies, which the Juvenile Court has determined to be an expenditure for a proper public purpose.

Pursuant to R.C. 319.16(D), "if the auditor questions the validity of [this] expenditure... the auditor shall notify the court that presented the documents, shall issue the warrant under protest, and shall notify the auditor of state of the protest."
