Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$15.00 (Fifteen Dollars and No Cents) from 1001-007-02-901 to BREEDLOVE, MADYSEN, at C/O JUVENILE COURT, 231 MAIN STREET, 2ND FLOOR, CHARDON, OH 44024, for notary reimbursement, which the Juvenile Court has determined to be an expenditure for a proper public purpose.


