

Pursuant to R.C. 2101.162(A)(2), 2151.541(A)(2), 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$198.52 (One Hundred Ninety Eight Dollars and Fifty Two Cents) from 4005-007-00-901 to VERIZON WIRELESS, at PO BOX 16810, NEWARD, NJ 07101-6810, for cell phone, which the Juvenile Court has determined to be an expenditure for a proper public purpose.

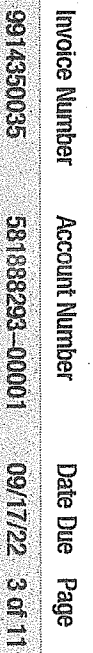
