Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$115.63 (One Hundred Fifteen Dollars and Sixty Three Cents) from 1001-007-02-701 to LBL LITHOGRAPHERS, at DBA: SHETLER OFFICE SOLUTIONS, PO BOX 1307, MIDDLEFIELD, OH 44062, for materials and supplies, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
