Pursuant to R.C. 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$27.66 (Twenty Seven Dollars and Sixty Six Cents) from 1001-008-00-901 to FEDERAL EXPRESS CORPORATION, at FEDEX, PO BOX 371461, PITTSBURGH, PA 15250-7461, for postage, which the Probate Court has determined to be an expenditure for a proper public purpose.
