Open Discussion

State's approval of Rules for electronic filing system.

Auditor Walder discussed that the Auditor's Office is looking at having an electronic filing system for the Board of Revision filers. The rules for electronic filing were submitted to the State, to which the State approved on December 20, 2022. Auditor Walder discussed the next phase is completing the online portal and sending that documentation to the State for final approval. Auditor Walder is looking to go paperless this year for the Board. Chief Deputy Administrator Antenucci stated we should be roughly two weeks away from completion of the portal. Treasurer Hitchcock asked where the information would be located so residents would be able to find the portal. Chief Deputy Administrator Antenucci discussed the pathway to find it on the Auditor's Site.

Parkman Wastewater Treatment Plant Discussion.

Auditor Walder discussed that some Parkman residents have stated that the new Wastewater Treatment Plant that was installed several years in that area, they feel the system has devalued their property values due to its vacuum system. This system leaves the traps dry and the smell of sewer gas infiltrates in their homes. Auditor Walder has a meeting next week with the Parkman area residents to get a better picture of what they are encountering. Treasurer Hitchcock stated that the Board may need to do a site visit in the future. Auditor Walder stated he would have additional information after his meeting next week with the residents.
