OAG opinion dated 12/14/22 regarding the Geauga Park district's authority to create a reserve fund among other things was shared by Mr. Flaiz. The opinion reaffirmed that the Park district is ineligible to create a reserve fund.

Housekeeping:

Tabled item from the June 29, 2022 meeting regarding the creation of the Land Acquisition Reserve Fund for the Geauga Park District; the Park District Board passed resolution 7-2022 on August 24, 2022 rescinding the motion to create the fund. The Budget Commission's motion has been resolved due to the Attorney General's opinion stating the park district may not create a reserve fund.

Geauga Park District discussion item from 12/5/22 meeting regarding appropriations to the Land Acquisition/Improvement Capital Reserve Fund. The Budget Staff worked with the GPD Interim Fiscal, Dawn, and the matter has been addressed at their Board meeting to rescind the resolution approving the appropriations. The issue has been resolved satisfactorily and the budget's fund numbers now match the Park's.

Tabled item from November 21, 2022 Geauga Public Health District Reserve Funds – revised resolution 2022-11 received. Still does not specify how the funds will be spent. Copy available for meeting.
