Pursuant to R.C. 5139.34(C)(3), 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$2,700.00 (Two Thousand Seven Hundred Dollars and No Cents) from 2005-007-70-601 to FORENSIC FLUIDS LABORATORIES, at 225 PARSONS ST, KALAMAZOO, MI 49007, for drug testing expenses, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
