Pursuant to R.C. 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$181.88 (One Hundred Eighty One Dollars and Eighty Eight Cents) from 1001-008-00-902 to LANDIS, HEIDI, at C/O JUVENILE/PROBATE COURT, CHARDON, OH 44024, for 2022 OAPJ Probate Clerks Conference mileage expenses, which the Probate Court has determined to be an expenditure for a proper public purpose.
