Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$40.36 (Forty Dollars and Thirty Six Cents) from 1001-007-02-906 to AT&T CORP, at P O BOX 5075, CAROL STREAM, IL 60197, for utilities, which the Juvenile Court has determined to be an expenditure for a proper public purpose.

Pursuant to R.C. 319.16(D), "if the auditor questions the validity of [this] expenditure... the auditor shall notify the court that presented the documents, shall issue the warrant under protest, and shall notify the auditor of state of the protest."

Attention Customers in Maine, North Carolina, Nevada, Utah and California:
