Pursuant to R.C. 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$750.00 (Seven Hundred Fifty Dollars and No Cents) from 1001-008-00-601 to GAZLEY, LUCINDA, at 16064 HIGH STREET, BURTON, OH 44021, for GAL fees for 22PG54, which the Probate Court has determined to be an expenditure for a proper public purpose.
