Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$850.00 (Eight Hundred Fifty Dollars and No Cents) from 1001-007-02-902 payable to MARION TECHNICAL COLLEGE, for 2022 OPOTA Court Officer Basic Training Course registration fee, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
