Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$2,700.00 (Two Thousand Seven Hundred Dollars and No Cents) from 1001-007-00-601 payable to FORENSIC FLUIDS LABORATORIES, for drug testing supplies, which the Juvenile Court has determined to be an expenditure for a proper public purpose. **Kindly provide this Court with the original check which it will mail to the vendor.**
