Pursuant to R.C. 2101.162(A)(2), 2151.541(A)(2), 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$3,735.50 (Three Thousand Seven Hundred Thirty Five Dollars and Fifty Cents) from 4005-007-00-901 payable to COMPANY 119 LTD, for website development, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
