Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$30.00 (Thirty Dollars and No Cents) from 1001-007-00-601 payable to GEAUGA COUNTY SHERIFF, for web check, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
