Pursuant to R.C. 5705.42, 2303.201(E)(1), 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$379.24 (Three Hundred Seventy Nine Dollars and Twenty Four Cents) from 2051-007-00-902 payable to SHUMWAY, MARY RUTH, for 45078, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
