This 6 day. 40 hour course is designed to provide basic semi-automatic pistol training for bailiffs. court security officers, court constables, probation officers, and other applicable court personnel.
The training will include weapon manipulation, weapon retention, fundamentals of marksmanship, reloads, malfunctions, multiple targets, use of cover/concealment, and alternative shooting positions. Students will also participate in decision-making training that will include threat identification and force on force scenarios.

Note: This course is broken up into 6 days over multiple weeks. There will be 3 consecutive days of training followed by several days off. Then the final 3 consecutive days of training. Any questions regarding the schedule can be sent to aaron.coey@ohioattorneygeneral.gov.

# Note: Ammunition will be provided.

Required Equipment: semi-automatic pistol. duty holster, 3 magazines, magazine holder, eye protection, hearing protection, ball cap, handheld flashlight/holder, and body armor. Students must wear appropriate clothing for possible weather changes. Students must also bring a coat, jacket, sweatshirt, or other long sleeve shirt for use during scenarios.
