Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$1,125.00 (One Thousand One Hundred Twenty Five Dollars and No Cents) from 1001-007-00-601 payable to ANN D'AMICO, for G.A.L. fees for 23 CU 6, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
