Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$74.02 (Seventy Four Dollars and Two Cents) from 1001-007-02-902 payable to MOORE MALLINOS, JENNIFER D, for employee mileage reimbusement, which the Juvenile Court has determined to be an expenditure for a proper public purpose.
