Pursuant to R.C. 2101.162(B)(1), 2151.541(B)(1), 2151.10, 2151.40, July 2000 orders issued by Judge Henry (copies attached), and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$11,876.25 (Eleven Thousand Eight Hundred Seventy Six Dollars and Twenty Five Cents) from 4004-007-00-901 payable to COURTVIEW JUSTICE SOLUTIONS, for support for the Ohio Supreme Court Technology Grant project, which the Juvenile Court has determined to be an expenditure for a proper public purpose. **Kindly provide this Court with the original check which it will mail to the vendor.**

Pursuant to R.C. 319.16(D), "if the auditor questions the validity of [this] expenditure... the auditor shall notify the court that presented the documents, shall issue the warrant under protest, and shall notify the auditor of state of the protest."

As an elected official and member of the judicial branch of county government, the Judge of the Geauga County Probate/Juvenile Court is authorized to fix the amount due to court vendors who perform services for the court. Therefore, pursuant to R.C. 307.55(A), this payment is to be processed "Live".



ORDER

I hereby determine that, for the efficient operation of the Court, additional funds are required to computerize the clerk's office, and I hereby authorize and direct the deputy clerks of this Court to charge an additional fee of \$7.00 on the filing of each cause of action or appeal, on the filing, docketing, and endorsing of each certificate of judgment, or on the docketing and indexing of each aid in execution or petition to vacate, revive, or modify a judgment under divisions (A), (P), (Q), (T), and (U) of Section 2303.20 of the Revised Code effective August 1, 2000. This fee is in addition to the \$3.00 fee imposed pursuant to Ohio Revised Code Section 2151.541(A)(1)(a).

All fees, so collected, shall be paid to the County Treasurer to be disbursed, upon an order of the Juvenile Court Judge and subject to appropriation by the Board of County Commissioners, in an amount no greater than the actual cost to the Juvenile Court of procuring and maintaining computer systems for the clerks' office.
