Pursuant to R.C. 2151.10, 2151.40, and 319.16(A)(2), this order hereby directs timely payment by the Geauga County Auditor in the amount of \$48.25 (Forty Eight Dollars and Twenty Five Cents) from 1001-007-00-601 payable to MOORE MALLINOS, JENNIFER D, for GAL fees for 10SU149, which the Juvenile Court has determined to be an expenditure for a proper public purpose. 


